Privacy Policy

Thank you for visiting Mahiti Kanaja, an online Public Information System managed by the Center for e-Governance, located in Bangalore, Karnataka. We have undertaken to respect and protect the privacy of our users to the best of our ability and awareness. This privacy policy will tell you how we collect and use information.

In this privacy policy, the term "Personal Information" refers to any information from which your identity is apparent or can be reasonably ascertained.

The Mahiti Kanaja website does not automatically capture any specific personal information from you, (like name, phone number or e-mail address), that allows us to identify you individually.

We do not transfer, distribute, sell or share any personally identifiable information volunteered on the website to any third party (public/private). However, if you provide personal information while you voluntarily seek information pertaining to another government agency or department, it is only used to fulfil your request for information.

We do gather certain technical information about you when you visit our site. We collect such technical information to make your visit seamless. The section below explains how we handle and collect technical information when you visit our website.

- The IP address (an IP address is a number that is automatically assigned to your computer whenever you are surfing the web) from which you access our website.

Cookie Policy:

We only use non-persistent cookies or "per-session cookies". 28 Per-session cookies serve technical purposes, like providing seamless navigation
